Gulf County Sheriff's Office (GCSO) Investigators and Deputies served the warrants today on the subjects. The cases were the result of investigations conducted by the GCSO Narcotics Unit.

McFarlane was recently arrested for Trafficking in Hydrocodone on June 26, 2014, and was released from the Gulf County Detention Facility (GCDF) on a \$25,000 bond. Brogdon is currently on drug offender probation after she was arrested on March 29, 2014, for Possession of Meth, Attempted Manufacture of Meth, Possession of Listed Chemicals, and Drug Paraphernalia. Gortman was arrested on multiple drug charges on August 21, 2014, to include Possession of Meth and Cocaine with Intent to Distribute. Gortman was out on a \$28,000 bond. All subjects were transported to the Gulf County Detention Facility and are awaiting first appearance.
