## **GCSO LAW ENFORCEMENT SUMMARY**

OCTOBER 20, 2014 - OCTOBER 26, 2014

On Monday, October 20<sup>th</sup>, the Gulf County Sheriff's Office (GCSO) executed an order to transport and traveled to Washington Correctional Institution to pick up Quentin T. Woodruff (29). Woodruff was due to appear in circuit court on October 21<sup>st</sup>. He was returned to the facility on October 22<sup>nd</sup>.

On October 20<sup>th</sup>, the GCSO traveled to the Bay County Jail to extradite Jesse T. Everett (33). Everett was held for the GCSO for Violation of Probation on her original charge of Possession of Meth and Drug Paraphernalia.

On October 20<sup>th</sup>, Deputy S. Ferrell arrested James R. Haney (38) in the 600 block of Bryants Landing Road in Dalkeith. The GCSO held an active Writ of Bodily Attachment. He was taken into custody and transported to the Gulf County Detention Facility (GCDF).

On Wednesday, October 22<sup>nd</sup>, the GCSO received a report of a possible residential burglary in the 1700 block of Indian Pass Road. Sgt. J. Williams responded to the call. A local resident near the address contacted the owner and informed them the back door to their home was open. The only items determined to be missing from the residence was alcoholic beverages.

On Thursday, October 23<sup>rd</sup>, the GCSO received a 911 call from the 600 block of Bryants Landing Road in reference to criminal mischief. Deputy G. Desrosier arrived on scene and determined that Tyler A. Bowles (26) damaged the door to a residence. He was taken in to custody and charged with Criminal Mischief. Bowles was transported to the GCDF where he was later first appeared and conditionally released.

On October 23<sup>rd</sup>, Inv. L. Greenwood arrested Kristian H. McDaniel (24) on one count of Scheme to Defraud. The arrest stems from the report of a theft on September 11, 2014, at the IGA in Wewahitchka. A prepaid credit card was activated and loaded with

approximately \$2,330. McDaniel is a former employee. She was transported to the GCDF where she was later first appeared and conditionally released.

On October 23<sup>rd</sup>, the GCSO received a complaint regarding a residential burglary in the 100 block of Grant Lane south of Wewahitchka. Deputy B. Smith responded to the call. Jewelry was stolen from the residence valued at approximately \$1,300. Investigator L. Dickey continues to investigate the case.

On Friday, October 24<sup>th</sup>, Deputy G. Desrosier arrested Anthony D. Russell (49) on a warrant for Failure to Appear. Russell was transported to the GCDF where he was later first appeared and released on his own recognizance.

On October 24<sup>th</sup>, Deputy B. Smith responded to the burglary of an automobile in the 6600 block of Ganley Road in Five Acre Farms. The complainant reported he observed someone at the vehicle and when he did the suspect fled on foot. The item reported stolen from the vehicle was a four pack of Steel Reserve Beer. The complainant reported he had left the vehicle unlocked.

On October 24<sup>th</sup>, Deputy M. Layfield arrested and served Carrie K. Strain (28) three arrest orders for contempt of court. She was transported to the GCDF.

On October 24<sup>th</sup>, Inv. L. Dickey arrested Rodney D. Johnson (37) on a traffic stop just north of Port St. Joe located on State Road (SR) 71. Johnson was arrested for Driving While License Suspended or Revoked (DWLS/R). He was transported to the GCDF.
