GCSO LAW ENFORCEMENT SUMMARY

JANUARY 5, 2015 – JANUARY 11, 2015

On Monday, January 5th, the GCSO executed two orders to transport by traveling to Florida State Prison in Raiford and to the Leon County Jail in Tallahassee. Quentin T. Woodruff (29) and Guillermo J. Rodriguez (36) were both transported to Gulf County to appear in circuit court on Tuesday, January 6th. Rodriguez was returned to the Leon County Jail at the conclusion of his proceeding. Woodruff remains in the custody of the Gulf County Detention Facility (GCDF).

On January 5th, Donald W. Harcus, Jr. (36) turned himself in at the GCSO on a Writ of Bodily Attachment for child support. Harcus was booked into the GCDF where he remains in custody on a \$2,500 purge or 180 days in jail.

On Tuesday, January 6th, Rachel L. List (25) turned herself in at the GCSO on a warrant for Violation of Probation. List is on probation for Grand Theft. She was booked into the GCDF and released on a \$2,500 bond.

On January 6th, Deputy G. Desrosier responded to the 800 block of Jones Homestead Road in reference to criminal mischief. The complainant returned to his residence and found his sliding glass door busted. No items were discovered missing from within the home. The case is still under investigation.

On January 6th, Deputy C. Harvey responded to the 1200 block of Stone Mill Creek Road after the GCSO received a 911 call regarding a domestic disturbance. At the conclusion of the investigation, Deputy Harvey arrested Selina R. Culpan (23) for Domestic Battery on a person 65 years or older. She was transported to the GCDF where she was later first appeared and conditionally released.

On January 6th, Sgt. J. Williams was contacted in the 2100 block of Parker Avenue in Highland View. The complainant reported the theft of a lime green 26 inch women's bicycle. The bicycle was valued at approximately \$100.

On Wednesday, January 7th, Deputy P. Williams responded to a criminal mischief complaint in the 100 block of Balboa Street in St. Joe Beach. The complainant noticed a substance in the bottom of their pool after returning home from out of town. The substance was determined to have left a stain and pits in the pool, which was made of fiberglass.

On January 7th, the GCSO received a complaint regarding a residential burglary in the 200 block of Sealy Drive in White City. Deputy P. Williams responded to the call. The complainant reported approximately \$1,050 in tools stolen. The residence was being remodeled and force was used to gain entry into the home. The items included three step ladders, a table saw and a trim gun. Investigator L. Greenwood continues to investigate the case.

On January 7th, Deputy M. Layfield responded to the report of a theft in the 900 block of Old Panama Highway in Wewahitchka. The complainant reported the theft of a large red air compressor and hose. The compressor was valued at approximately \$400.

On Thursday, January 8th, the GCSO received a complaint regarding the burglary of an automobile. Deputy M. Layfield made contact with the complainant, who reported the theft of a foam scraper valued at \$2,000. The offense occurred in the 200 block of Catalpa Avenue in Wewahitchka. Investigator L. Greenwood continues to investigate the case.

On January 8th, Deputy P. Baxley was on patrol in the 4000 block of Cape San Blas Road when he observed a vehicle exceeding the posted speed limit. A traffic stop was conducted on the vehicle and contact was made with the driver, Homer A. Davis (53). It was determined Davis was operating the vehicle without a valid driver's license. He was arrested and transported to the GCDF where he was later conditionally released. Davis was also issued a citation for speed.

On January 8th, the GCSO received a complaint regarding a residential burglary in the 200 block of Gulf Pines Drive near Cape San Blas. Deputy P. Williams responded to call. The complainant reported the burglary of the residence which resulted in the theft of two television sets and a dvd player. The total value of the items stolen was approximately \$350. Investigator L. Dickey continues to investigate the case.

On January 8th, the GCSO received a 911 call from the area of State Road (SR) 71 and Britt Avenue in Wewahitchka. The caller advised she was broken down in the middle of nowhere and needed help. Deputy C. Sanders responded to the call and made contact with the complainant Melissa L. Davis (33). Prior to this call the GCSO had received a complaint of a reckless driver, which matched the description of the vehicle operated by Davis. During the investigation it was determined that Davis had attached a tag to the vehicle that was not assigned to it. Davis admitted to removing the tag from another vehicle she owned and placing it on the vehicle she was driving. Deputy Sanders placed her under arrest for attaching a tag not assigned to the vehicle. As a result of an inventory of the vehicle prior to it being towed, Davis was found in possession of meth

and drug paraphernalia. She was transported to the GCDF and charged with the offenses. She was later first appeared and remains in custody. Davis was out on bond for Possession of Meth and Drug Paraphernalia.

On Friday, January 9th, Travis K. Woullard (33) turned himself in on a warrant for Failure to Appear. Woullard was out on bail for Possession of Less than Twenty Grams of Marijuana. He was booked in and conditionally released.

On January 9th, the GCSO received a complaint regarding a trespass in the 100 block of Pope Avenue north of Wewahitchka. Deputy B. Smith responded to the complaint. Contact was made with Gary A. Roberts (37) who was found on the property removing fuel from a lawn mower. He was arrested and charged with Theft. Roberts was first appeared and released on a \$10,000 bond.

On January 9th, the GCSO received another report of a residential burglary in the 200 block of Gulf Pines Drive near Cape San Blas. The GCSO responded to the location earlier in the week after two televisions and a dvd player was stolen. Deputy J. Oquendo responded to the complaint. A stacked washer and dryer was stolen from the residence valued at approximately \$1,000. There were no signs of forced entry. Investigator L. Dickey continues to investigate the case.

On Saturday, January 10th, Deputy B. Smith responded to the 9500 block of County Road 30-A in Indian Pass. The GCSO received a complaint regarding a residential burglary. Multiple bottles of liquor were stolen from within the residence. There were no signs of forced entry. Investigator L. Dickey continues to investigate the case.

On January 10th, at approximately 9:24 pm Deputy C. Harvey stopped a vehicle driven by Matthew D. Meredith (26) after the vehicle ran the redlight in Wewahitchka. Meredith stated that he ran the light because it takes too long to change. It was determined his driver's license was suspended and that Meredith was on probation with a curfew of 7:00 pm. He was arrested and charged with Driving While License Suspended/Revoked (DWLS/R) and Violation of Probation. Meredith was transported to the GCDF where he was last first appeared. He remains in custody.

On January 10th, Sgt. J. Williams stopped a vehicle for exceeding the posted speed. Contact was made with the driver, Shanteria L. Brown (29), who told Sgt. Williams that she was just arrested for DWLS/R and was not supposed to drive. It was confirmed Brown was operating the vehicle on a suspended license. She was arrested for DWLS/R and transported to the GCDF. Brown was first appeared and released on a \$5,000 bond.

On Sunday, January 11th, the GCSO received a complaint regarding a theft in the area of Woodmere Drive in Honeyville. Deputy B. Smith responded to the call and made contact with the complainant. The complainant reported the theft of a Troy Built 5500 watt generator. The generator was valued at approximately \$500. The offense occurred at some point during the past two weeks.

On January 11th, Deputy C. Harvey observed Daniel R. Graney (56) operating a vehicle in the area of Garrison Avenue in Port St. Joe. Deputy Harvey had prior knowledge that Graney's driver's license was suspended for failure to pay traffic fines. A traffic stop was conducted on Madison Street near Long Avenue in Port St. Joe where it was confirmed Graney was operating the vehicle on a suspended license. He was arrested and transported to the GCDF for DWLS/R. He was first appeared and conditionally released.
