Gulf County Sheriff's Office (GCSO) Investigators and Deputies served warrants on the subjects today. The cases are the result of investigations conducted by the GCSO Narcotics Unit.

Joseph T. Adkison (23) was served with a warrant for the Sale of Meth within 1,000 Feet of a Park at the Jackson County Jail where he is in custody. Three of the subjects face additional charges. At the time of Michael A. Hammond's arrest, he was found in possession of meth and drug paraphernalia. Jerome D. Russ

was recently sentenced to felony probation for drug possession and was charged with Violation of Probation. At the time of Wesley E. Ramsey's arrest, he was found in possession of marijuana and drug paraphernalia. The arrests totaled 24 felony and three misdemeanor charges. All subjects were transported and booked into the Gulf County Detention Facility and first appeared.
