### **GCSO LAW ENFORCEMENT SUMMARY**

APRIL 27, 2015 – MAY 3, 2015

On Monday, April 27<sup>th</sup>, Investigator J. Hanson and Deputy S. Ferrell arrested Lisa R. Jamerson (42), in the 600 block of Bryants Landing Road, on an arrest order for Failure to Appear in County Court. Jamerson failed to appear on her original charge of the Sale of Alcohol to a Person Under 21. She was transported to the Gulf County Detention Facility (GCDF).

On April 27<sup>th</sup>, Deputy G. Desrosier arrested Richard K. Helms, Jr. (41) in the 600 block of Jehu Road in Wewahitchka. Helms was wanted by the Bay County Sheriff's Office on a Writ of Bodily Attachment. He was transported to the GCDF.

On Tuesday, April 28<sup>th</sup>, Deputy J. Oquendo responded to the 300 block of East Creekview Drive in Stone Mill Creek. The GCSO received a complaint regarding the theft of gasoline.
