GCSO LAW ENFORCEMENT SUMMARY

JUNE 22, 2015 – JUNE 28, 2015

On Monday, June 22th, the Gulf County Sheriff's Office (GCSO) executed two transport orders by traveling to the Walton Correctional Institution, in Defuniak Springs, and the Bay County Jail. Freddie L. Granger (54) and Thomas K. Lee, Jr. (23), were scheduled to appear in circuit court on June 23rd, they were returned to their respective facilities on Wednesday, June 24th.

On June 22nd, Deputy B. Smith arrested Richard L. Winters (55) on a warrant for Battery. Winters turned himself in at the GCSO. He was booked into the Gulf County Detention Facility (GCDF).

On Tuesday, June 23rd, the GCSO executed a transport order by traveling to the Jackson County Correctional Facility, in Marianna. Ladora L. Nunnery (45) was scheduled to appear in circuit court. She was returned the same day with the assistance of the GCDF.

On June 23rd, Sgt. J. Williams conducted a traffic stop in the area of State Road (SR) 71 and East Orange Avenue in Wewahitchka. The driver, Nicole T. White (26), was operating the vehicle on a suspended license. White was arrested for Driving While License Suspended/Revoked (DWLS/R) and transported to the GCDF.

On June 23rd, Deputy P. Beuligmann served an arrest warrant on Renell Thomas (59) for Violation of Probation. Thomas was already in the custody of the GCDF.

On June 23rd, Carlos D. Rhodes (42) turned himself in at the GCSO. Rhodes had an active warrant for Violation of Probation on his original charge of DWLS/R. Deputy M. Ward served the warrant and Rhodes was booked into the GCDF.

On Wednesday, June 24th, Sgt. R. Burkett served Edward A. Colon (45) with a warrant for Violation of Probation on his original charge of Grand Theft. Colon arrived at the GCDF after he was taken into custody by the Pennsylvania State Police on May 29th, 2015. Colon was extradited back to Gulf County on the warrant.

On June 24th, Deputy D. Sanders responded to the 500 block of Lands Drive in Wewahitchka in reference to the burglary of a vehicle. The complainant reported the theft of a wallet and checks. The offense was reported to have occurred at Lands Landing. The vehicle was not locked.

On Thursday, June 25th, Investigator J. Hanson conducted a traffic stop in the 100 block of South SR 71 in Wewahitchka. The driver, Shawna M. O'Bryan (27), was operating the vehicle on a suspended license. She was placed under arrest and transported to the GCDF.

On June 25th, Deputy B. Smith responded to the 100 block of Summer House Lane on Cape San Blas in reference to a residential burglary. The complainant discovered the residence was entered after finding a busted window. Once inside, it was discovered a 32" Insignia and a 42" Coby television were stolen from the residence. While at the residence, it was discovered the home next door was also burglarized. One television was also stolen from it. The scenes were processed for evidence and the cases remain under investigation.

On June 25th, Investigator J. Hanson arrested Joann P. Wilder (57) in the 100 block of Burgess Creek Road in Dalkeith. Wilder was wanted for Violation of Probation on her original charge of the Sale of Methamphetamine. Wilder was transported to the GCDF.

On June 25th, Deputy M. Layfield arrested James A. Clark (58) for Violation of Probation in the 100 block of Hensley Lane in Overstreet. Contact was made with Clark after a 911 call over a verbal disturbance between he and his girlfriend was made. Clark was on probation for two counts of Contracting without a Certificate. He was transported to the GCDF.

On Friday, June 26th, the GCSO received a 911 call regarding an unknown disturbance in the 5800 block of Ganley Road in Five Acre Farms. Deputy G. Desrosier responded to investigate. The call resulted in the arrest of Michael D. Harrell, Jr., (19) for Domestic Battery. Harrell was transported to the GCDF.

On Saturday, June 27th, Deputy P. Beuligmann responded to the 100 block of April Lane in Stone Mill Creek in reference to a theft. The complainant reported the theft of lumber from the yard of the residence. The lumber was described as approximately ten twelve foot 2x6 boards and thirty eight to twelve foot 2x4.

On Sunday, June 28th, Deputy C. Harvey assisted the FWC with a traffic stop on the beach just west of Salinas Park. The stopped resulted in the arrested Timothy C. O'Bryan, Sr., (55) for Possession of Less Than Twenty Grams of Marijuana and Possession of Drug Paraphernalia. O'Bryan was transported to the GCDF.
