### **GCSO LAW ENFORCEMENT SUMMARY**

JUNE 29, 2015 – JULY 5, 2015

On Monday, June 29<sup>th</sup>, Bobby G. Creamer, III, (24) turned himself in at the Gulf County Sheriff's Office (GCSO). Creamer was wanted for Violation of Probation on his original charge of Grand Theft. He was turned over to the staff at the Gulf County Detention Facility (GCDF).

On June 29<sup>th</sup>, Christopher D. Parmele (49) was arrested and served with a Writ of Bodily Attachment by Deputy D. Wisner after he turned himself in at the GCSO. He was booked into the GCDF.

On June 29<sup>th</sup>, the GCSO received a 911 call regarding an assault in the 300 block of East Reid Avenue in Wewahitchka. Deputy D. Sanders responded to investigate the complaint. The complainant reported Cindy A. Gaskin (55) assaulted her with an aluminum baseball bat after a dispute over property. Deputy Sanders substantiated the report after making contact with Gaskin. Gaskin was placed under arrest for Aggravated Assault with a Deadly Weapon on an elderly person.

On June 29<sup>th</sup>, the GCSO received a 911 call regarding an assault in the 200 block of Sparrow Lane in Overstreet. Sgt. C. Dixon and Deputy C. Harvey responded to the complaint which involved the discharge of a firearm. The investigation resulted in the arrest of Kevin J. Krum (58) for Aggravated Assault with a Deadly Weapon. Krum was transported to the GCDF.

On Tuesday, June 30<sup>th</sup>, Deputy D. Sanders responded to the 900 block of West Rutherford Street in Jones Homestead after the GCSO received a complaint of a stolen tag. The complainant went to place a new decal on a trailer tag, but discovered it stolen. The theft took place between June 28<sup>th</sup> and June 30<sup>th</sup>. The Florida tag number was 1812IZ.

On June 30<sup>th</sup>, the GCSO received a complaint regarding the theft of a bicycle in the 500 block of Dolphin Street. Deputy M. Layfield responded and investigated the case. The complainant reported Steven M. Arthur (22) had stolen their bicycle after he was told he couldn't take it. The

bike was recovered. At the conclusion of the investigation, Deputy Layfield arrested Arthur for Petit Theft and transported him to the GCDF.

On Wednesday, July 1<sup>st</sup>, Deputy G. Desrosier responded to the GCSO Substation in Wewahitchka to make contact with a complainant in regards to Criminal Mischief. A gate located on Road 14 and State Road (SR) 22 was maliciously damaged by a vehicle. The vehicle was described as a gray or silver Toyota FJ Cruiser. Deputy Desrosier continues to investigate.

On July 1<sup>st</sup>, the GCSO received a 911 call regarding a disturbance in the 1800 block of SR 71 South in Wewahitchka. Deputy G. Desrosier responded to the complaint which resulted in the arrest of James A. Robbins (51) for Disorderly Intoxication. When Deputy P. Beuligmann attempted to take Robbins into custody he resisted arrest. Robbins was transported to the GCDF and charged with Disorderly Intoxication and Resisting a Law Enforcement Officer without Violence.

On Thursday, July 2<sup>nd</sup>, the GCSO traveled to the Leon County Jail to transport Charles J. Hooper (27) back to the GCDF. Hooper was out of the GCDF on an Order to Transport to Pinellas County. Hooper is scheduled to appear in circuit court on July 7<sup>th</sup> for a sentencing hearing.

On July 2<sup>nd</sup>, Sgt. J. Williams arrested Shawna M. O'Bryan (27) after she turned herself in at the GCDF. O'Bryan was wanted for Violation of Probation on her original charge of Battery. She was turned over to the staff at the GCDF.

On June 2<sup>nd</sup>, Deputy P. Baxley conducted a traffic stop in the 3000 block of Doc Whitfield Road in Howard Creek. The vehicle was traveling 75 mph in a posted 55 mph zone. The driver, Scott L. Hopper (49), was operating the vehicle on a suspended driver license. He was subsequently arrested for Driving While License Suspended/Revoked (DWLS/R) and transported to the GCDF.

On Friday, July 3<sup>rd</sup>, the GCSO traveled to the Bay County Jail to extradite Stephen J. Heathcock (20) back to Gulf County. Heathcock was arrested in Bay County on a warrant for Violation of Probation issued in Gulf County. Heathcock is on probation for Child Abuse. He was transported to the GCDF.

On July 3<sup>rd</sup>, Deputy D. Sanders conducted a traffic stop on a vehicle in the area of West River Road near the IGA for a traffic violation. The driver, Elise S. Bogle (31), was wanted by the GCSO for Burglary and Dealing in Stolen Property. The case, which originated May 18<sup>th</sup>, was investigated by Investigator L. Greenwood and occurred in the 3500 block of County Road (CR) 386.

On July 3<sup>rd</sup>, the GCSO received a complaint of a burglary in the 100 block of Ernie Drive in Wewahitchka. The complainant reported the theft of a Husqvarna Weed Eater, two red plastic gas cans, and a brown folding chair from a shed. The offense is believed to occurred between July 1<sup>st</sup> and July 3<sup>rd</sup>. The case remains under investigation.

On July 3<sup>rd</sup>, Deputy P. Williams arrested Pamela R. Parrish (33) in the 100 block of Woodmere Drive in Honeyville. Parrish was taken into custody on a Writ of Bodily Attachment for Child Support. She was transported to the GCDF.

On July 3<sup>rd</sup>, Richard L. Mullinax (63) was arrested by Deputy P. Williams in the 100 block of Horseshoe Drive north of Wewahitchka. Mullinax was arrested for Violation of Probation on his original charge of Attaching a Tag Not Assigned to a Vehicle and No Vehicle Registration.

On Saturday, July 4<sup>th</sup>, Deputy P. Williams arrested Curt L. Johnson (31) in the 100 block of Crestwood Lane north of Wewahitchka. Johnson was wanted by the Bay County Sheriff's Office on two misdemeanor warrants. He was transported to the GCDF.

On July 4<sup>th</sup>, the GCSO received a 911 call regarding a physical disturbance in the 200 block of Our Town Road north of Wewahitchka. Deputy P. Beuligmann and Deputy C. Caro responded to investigate. It was determined to be a domestic disturbance, which resulted in the arrest of Zeikel P. Pitts (36). Pitts was transported to the GCDF and charged with Aggravated Battery (Domestic).
