GCSO LAW ENFORCEMENT SUMMARY

April 18, 2016 – April 24, 2016

On Monday, April 18, 2016, Justin Demond Jackson (37) was arrested by Deputy S. Cook at the Gulf County Detention Facility (GCDF) for a Failure to Appear arrest warrant.

On April 18, the Gulf County Sheriff's Office (GCSO) received a complaint of a domestic disturbance in the 100 block of North Patrick Street in Overstreet. The domestic disturbance was reported to have been physical in nature. Deputy M. Peek and Sgt. R. Burkett responded to the scene to investigate. The victim reported to the deputies her cohabitant, William Farrell Dobbins Jr. (54) had battered her but had fled the scene prior to their arrival. After the deputy's initial investigation was complete they departed the scene attempting to locate Dobbins. The investigation revealed a physical struggle had taken place. Several hours later the GCSO received a 911 call stating Dobbins had returned to the residence. Deputy M. Peek and Sgt. R. Burkett returned to the residence and located Dobbins in the backyard where he was arrested. Dobbins was charged with Domestic Battery and transported to the GCDF.

On Tuesday, April 19, 2016, the GCSO received a complaint of a domestic disturbance in the 100 block of Gone Fishing Street in Wewahitchka. Deputy C. Harvey responded to call to conduct an investigation. When Deputy C. Harvey arrived on scene he observed Warren Mitchell Bowers (30) chasing a male and female on foot in the street. Deputy C. Harvey shouted verbal commands to Bowers to stop but Bowers did not comply continuing to chase the male and female. Deputy C. Harvey engaged in a foot chase after Bowers, subsequently apprehending him. The investigation revealed Bowers had battered two separate victims at the residence and was arrested. Bowers was charged with one count of Battery, and one count of Domestic Battery. He was transported to the GCDF.

On April 19, Investigator P. Williams conducted a traffic stop on a white sport utility vehicle driven by Jimmy Hammond (26) for inoperative taillights. Hammond produced only an identification card to Investigator Williams. A driver license check revealed he

was operating a motor vehicle on suspended license. Hammond was arrested and charged with Knowingly Driving on a Suspended Driver License. He was transported to the GCDF.

On April 19, the GCSO received a complaint of criminal mischief in the 200 block of Hill Top Drive in Stone Mill Creek. Deputy M. Peek responded to investigate. The complainant reported a white Toyota truck, and a black truck (unknown make/model) were driving at a high rate of speed on Hill Top Drive. It was reported the white Toyota lost control and collided with a fence. The white Toyota truck fled the scene. The complainant estimated the damage to be approximately \$30.00. Deputy M. Peek continues to investigate.

On Thursday, April 21, 2016, Bobbi Jo Kathleen Duke (25) was arrested by Deputy M. Peek at the (GCDF) for a Violation of Probation arrest warrant.

On Friday, April 22, 2016, the GCSO received a complaint of a person who was in violation of a Pre-Trial Release Program condition in the 1600 block of County Road 381 in Dalkeith. Deputy P. Baxley responded to conduct an investigation. The investigation revealed Ronald Leon Wilson (51) was in violation of a Pre-Trial Release Program stemming from a previous Domestic Battery charge. Wilson was arrested and transported to the GCDF.
