GCSO LAW ENFORCEMENT SUMMARY

October 17, 2016 – October 23, 2016

On Monday, October 17, 2016, Deputy M. Peek arrested Brandi Ellise Brogdon (38) in the 100 block of Mitchell Road in Wewahitchka. Brogdon had an arrest warrant for Violation of Probation. Brogdon was transported to the Gulf County Detention Facility (GCDF).

On October 17, 2016, the Gulf County Sheriff's Office (GCSO) received a domestic disturbance complaint in the 300 block of East River Road in Wewahitchka. Deputy M. Peek responded to the complaint to conduct an investigation. The disturbance was between an aunt and her adult niece. The complainant did not want to pursue criminal charges and signed a Declaration of Intent requesting no further investigation be conducted.

On October 17, 2016, Deputy C. Harvey and Deputy P. Baxley arrived in the 200 block of James Drive in Wewahitchka to arrest David Sean Roberts (44) who was wanted by the Bay County Sheriff's Office (BCSO) on six active warrants. The deputies found no one to be home and as they were leaving the residence a black Chevrolet truck pulled into the driveway. Roberts was a passenger in the vehicle and was arrested for the BCSO warrants. The vehicle was driven by Robert Thomas Burch (36). A driver's license check revealed Burch was driving on suspended license. Burch was arrested and charged with Driving While License Suspended or Revoked. Burch and Thomas were transported to the GCDF.

On October 17, 2016, Deputy P. Baxley was flagged down by a complainant at the intersection of State Road 71 & East Orange Avenue in Wewahitchka.

The complainant reported their vehicle had been stolen from the 300 block of Byrd Parker Drive in Wewahitchka. The vehicle is described as a 1998 Toyota 4x4 regular cab truck, red in color with a diamond plate tool box, Florida Tag No: 102QYV. The GCSO continues to investigate.

On Tuesday, October 18, 2016, Captain C. Buchanan served Jimmy Hammond (27) with a Violation of Probation arrest warrant at the GCDF. Hammond was delivered to the GCDF.

On October 18, 2016, Deputy P. Baxley served Charles Ernest Anderson III (18) with a Failure to Appear arrest warrant at the GCDF. Anderson was delivered to the GCDF.

On Thursday, October 20, 2016, Deputy D. Sanders arrested David John Dicho (52) in the 200 block of Ward Street in St. Joe Beach for a Failure to Appear arrest warrant. Dicho was transported to the GCDF.

On October 20, 2016, the GCSO received a walk-in theft complaint. Deputy D. Sanders responded to the complaint. The complainant reported their vehicle license plate had been stolen from their vehicle. Deputy Sanders continues to investigate.

On October 20, 2016, Deputy D. Sanders arrested Glen Paul Rushing (42) in the 2400 block of McKinnon Street in Oak Grove for a Violation of Probation arrest warrant. Rushing was transported to the GCDF.

On October 20, 2016, the GCSO received a commercial burglary complaint in the 600 block of Big Daddy Nook Road in Wewahitchka. Deputy C. Smith responded to the complaint to conduct an investigation. The investigation revealed three chainsaws and a 5,000 pound winch were stolen during the burglary. The chainsaws are described as (2) Jonsenred's, red in color with 32 inch bars and (1) Husqvarna with an 18 inch bar. This investigation has been assigned to the GCSO Criminal Investigations Division (CID).

On October 20, 2016, Deputy A. White executed a transport order and transported Rashed Omar Brown (34) from the Bay County Jail to the GCDF. The GCSO held an active warrant for Failure to Appear.

On October 20, 2016, the GCSO received two 911 calls from callers who stated gunshots were being fired in the 1100 block of Old Transfer Road in

the Land's Landing area. Deputy G. Desrosier responded to the scene to conduct an investigation. The investigation revealed James Alfred Robbins (52) was intoxicated and carelessly fire three gunshots in the direction of residences. Prior to law enforcement arrival Robbins retreated back inside his residence with the firearm. Deputy Desrosier made several attempts to make contact with Robbins at his residence but received no response from him. The GCSO SWAT team was notified and responded to the scene. The SWAT team was able to gain entry to Robbins residence and take him into custody without incident. Robbins was arrested and charged with Using Firearm while Under the Influence. Robbins was transported to the GCDF.

On Friday, October 21, 2016, the GCSO received a field contact request in the 200 block of West Avenue in Wewahitchka. Deputy M. Peek responded to the request to meet with the complainant. The complainant reported having problems with an individual identified as William Harley Brown (21) and requested a trespass warning be issued. Subsequently a trespass warning was served to Brown to stay away from the complainant's residence. The GCSO received a call from the complainant stating Brown was back on their property attempted to break into their shed. Deputy C. Harvey responded and located Brown behind the shed where he was taken into custody. Brown was arrested and charged with Trespass after Warning. Brown was transported to the GCDF.
