GCSO LAW ENFORCEMENT SUMMARY

NOVEMBER 20, 2017 - NOVEMBER 26, 2017

On November 20, Sgt. J. Williams stopped a vehicle for a traffic infraction on Hwy 98 near Avenue A. Sgt. Williams identified the driver as Cedric Rando Murry (38) and discovered that his driver's license was revoked in 2010. Murry was arrested and charged accordingly.

On November 20, Investigators P. Williams and S. Ferrell located Charles Earl Hood Sr. (43) in the 1600 block of Hwy 22 and arrested him a probation violation warrant. Hood was on probation for Aggravated Battery, Assault and False Imprisonment.

On November 20, William Lee Nunery Jr. (45) was arrested for Arson following a fire investigation which began on October 30, 2017, where Nunery's neighbor found his wooden door step on fire. The investigation included the Florida State Fire Marshal's Office who ultimately brought the charges forth against Nunery once they determined that Nunery was responsible for starting the fire.

On November 22, Deputy P. Young was assigned to investigate a fraud report on Griffin Road in Stonemill Creek. It was reported that unknown persons had obtained personal information from the victim and fraudulently obtained a credit card. The victims realized what had happened when they received a bill in the mail from the credit card company. A suspect has been identified but no arrests have been made at this time.

On November 22, Investigators P. Williams and S. Ferrell arrested Jessica Nicole Brock (35) on a warrant for failing to appear in court. Brock was to appear in court to charges of Possession of a Controlled Substance and driving with a suspended driver's license.

On November 22, Deputy L. Greenwood was dispatched to the 300 block of East River Road in reference to the theft of medication. Deputy Greenwood collected evidence from the scene, which enabled him to identify a suspect. Criminal charges against the suspect are pending.

On November 23, Deputy C. Harvey conducted a traffic stop on CR 386 near Pleasant Rest Cemetery Road for a traffic violation. Deputy Harvey identified the driver as Anthony Scott Crocker (34) and learned that Crocker was wanted in Bay County for failing to pay child support. Crocker was taken into custody and transported to the Gulf County Detention Facility.

On November 25, Deputy D. Sanders and Deputy C. Harvey responded to a report of a verbal altercation in 500 block of Williamsburg Avenue. When deputies arrived on scene they found Warren Mitchell Bowers (31) acting in a belligerent state, trying to get into a residence. Bowers was in an argument with someone inside the home and was refusing to disengage. Deputies attempted to get Bowers to calm down and explain what the problem was. Bowers refused to comply and became increasingly belligerent and disruptive. Bowers was arrested and charged with Disorderly Intoxication and Resisting Law Enforcement without Violence.
